**MAYOR IMPOSES CITYWIDE PARKING BANS**

**EFFECTIVE: \_\_\_\_\_  
SNOW EMERGENCY ROUTES  
RESIDENTIAL EVEN-SIDE PARKING ONLY AND  
DOWNTOWN PARKING BAN IN EFFECT**

Mayor John DeStefano, Jr , in anticipation of a Significant Snow Storm has declared a snow emergency for snow removal purposes and has announced the following parking bans:

Effective at: \_\_\_\_\_ **A Parking Ban is in effect requiring no parking on all posted snow routes is imposed.**

Effective at: \_\_\_\_\_ **A Parking Ban is in effect requiring parking on the EVEN SIDE only.**

Effective at : \_\_\_\_\_ Downtown Area (all streets within the area bounded by Howe Street, Tower Parkway, Grove Street, State Street and North Frontage Road) **PARKING BAN IMPOSED.**

Mayor DeStefano announced also that the City's Emergency Operations Center will open at \_\_\_\_\_ and remain open until further notice to assist residents with storm related problems or questions. Residents needing help are advised to call **946-SNOW** (7669),

Mayor DeStefano urged the public's cooperation in complying with the parking bans in order to assist the plowing operation. "Predictions are for a severe storm. I urge people to exercise caution and observe the parking bans. We must keep the streets open for emergency vehicles," Mayor DeStefano noted.
